2023 End of Session Letter

On Monday, April 10th, 2023, our 445th Session of the Maryland General Assembly was complete. I deeply appreciate your wonderful

support and input as we continue to "raise the bar" for our 24th Legislative District and County. Many of the decisions in Annapolis

are difficult and require many hours of thought and process, I have voted with a focused and firm conviction in protecting your interests. While many bills passed and failed, I want to share some of the most important legislation which directly impact our communities and lays the foundation for future generations.

However, many families experienced frustration and conflicting information about their accounts in the pre-paid plan. To address this issue, and to address the security of these investments, Senator Benson with several of her colleagues, introduced Senate Bill 959 which has passed legislation. This bill aims to reform the State's college savings program. The bill will transfer the administration of the program and the fiduciary responsibility for the program to the State Treasurer. The bill calls for the repeal of the Maryland 529 Board and instead entrusts the board's duties to the Treasurer. Additionally, the bill phases out the pre-paid plan and allows account holders to transfer their funds to the college savings investment plan, which operates without issue. Importantly, the bill also establishes a claims process for those account holders that seek a financial remedy from the program's trust. These measures aim to create a more reliable financial investment system for Maryland parents, allowing them to provide their children with a quality education. Cancer Screening



OFFICIAL SE The Town of Capitol Heights was established in 1910 as a municipal organization with the aim of offering public services to its members, including a place where they could go to perform their civic duties. We want to make sure we give citizens a suitable location to voice any community problems to their local government, which is why the project has now received 200 thousand dollars in order to support the cost of construction. The Project will add space to the existing Capitol Heights Town Hall that will include a second-floor addition of 4,000 square feet for a Community Center; which will serve as a venue for events and meetings for townwide services that benefits families, children, elders, and veterans. The project will also involve expanding the Council Chambers at Town Hall by 1,250 square feet, giving locals a larger area to attend public meetings. This project will amass roughly over 6000 square feet, all for the citizens of Capital Heights to be able to use, to conduct their local operations for their municipality.

The acquisition, planning, design, construction, and capital equipment of the property is currently being funded with an acquisition of 100 hundred thousand dollars to restore the community and town center. The project is particularly exciting since it will soon be built, providing the community with visible evidence of Prince George's County's infrastructure accomplishments. The new town center will feature a modern design of high-quality amenities that will cater to the needs of the community. Bond Bills Town of Capitol Heights Community Center


In Maryland, sixteen percent of the population are classified as elderly, and eleven percent of people have impairments; when added together, they make up a total of twenty-seven percent of



This legislation is critical in providing fair working conditions for personal care workers throughout the state, as it assigns a reasonable wage to each worker within medical agencies. Ninety percent of home care employees in Maryland are women. Their average hourly wage in Maryland is only \$14, leaving them underpaid and exhausted, potentially jeopardizing the quality of care given to this population in need. This bill ensures that our caregivers are properly protected while also compensating them for their efforts by raising the hourly wage from \$14 to \$16. This legislation only pertains to Medicaid home care provided by the office of Long-Term Services and Supports of the Department of Health. The goal of this legislation is to increase the Medicaid reimbursement rates for home care from \$23 SB: 334 Income Tax - Caregiver Tax Credit
